# Day to Day Challenges

- Loneliness, lack of companionship need someone to listen.
- Relying on professionals to do their jobs.
- Financial Hardship, struggling to eat.
- Feeling frustrated with the cared for, which makes the carer feel quilty.
- · Lack of communication with carers.
- Difficulty working sleep deprived.
- Need a disabled parking space.
- Unpredictable and changing routines are exhausting.
- Gave up work to care.
- Receiving calls back.
- · Lack of social workers.
- We need legal advice.
- Too busy to make plans.
- Involve Carers in the plans.
- People deteriorate future care.
- "Anticipatory Care Plan" jargon!
- Can't always rely on family members.
- Difficult, everyone's situation is different.
- Having appropriate housing for future needs.
- Long term services in order to plan long term.
- Legal route what does the cared for person want?
- If the "here and now" isn't working, you can't future plan.
- POA/Guardianship: yes, more knowledge about this is needed, (legal rights, what is needed, how and who you contact for this).

### **Short Breaks**

Hillend residential unit - one worker to one person. •

No confirmation of respite until two weeks before. •

Affordability - who is paying for food, petrol etc. •

Carers unsure of what they are entitled to. •

Support needed to go on short breaks. •

Alternative Breaks - bowling, zoomba • gym and swimming passes.

Funding officer, work with local orgs. •

Caravan Breaks allow you to remain • undisturbed, cheaper than a hotel.

Increased funding for short breaks. •

Need permanent respite facility. •

Funding for a companion. •

Transport barriers. •

Lack of - consultation by doctors. •

Advertising on Community Radio. •

Lack of communication between •

hospitals, confusion about discharge.

Carers unable to access GP/Dentist. •

Don't want people prying into your affairs. •

You might not want strangers in your house. •

Free newspaper for all Inverclyde Residents. •

Lack of time - consultation needs to come to them. •

Involve Carers in strategic planning - working group. •

Barriers to providing feedback, receiving information. •

Local adverts on TV (wouldn't work as well for young carers). •

#### What are the next steps?

We have listened to Carers and we have heard where support works and where we need to improve. The next steps will be:

- 1. Setting up short life work streams to develop the new refreshed Carers Strategy 2024-29 in response to what Carers have told us we need to improve on or develop new ways of working.
- These groups will focus on the four areas:
   Day to Day Support
   Hospital Discharge
   Respite/Short Breaks.
   Future Needs Planning
- 3. We will contact those Carers who came forward at the event to take part in these groups, we are still looking for volunteers.
- 4. We will continue the engagement work with Young Carers and Young Adult Carers.
- 5. We will consider if Inverclyde needs a separate Strategy for Young Carers and Young Adult Carers not a combined strategy as needs are different.
- 6. We will review the eligibility criteria for Carers.
